HIGH SCHOOL PARTICIPATION AGREEMENT – 2020 to 2021 Season

Please Note: For the safety of your students, coaches, school, and the NYCFL, this Participation Agreement must be in the NYCFL's hands before your team participates in its first tournament of the year. Adult coach and principal/head of school signatures are required.

If it is not possible to get a principal signature, then the principal may send an email (from their school account) to NYCFLtreasurer@gmail.com stating that they have seen this participation agreement and will comply with its terms.

This form serves as evidence that your school is aware that students are members of the NYCFL and has school administration permission to participate in speech and debate activities and agree to the following:

- 1) At all NYCFL tournaments the school will designate an 'adult in charge' with full authority to make decisions on behalf of your students. They will serve as the chaperone and can speak with tab staff to represent your students.
- 2) The signatures on this document signify that your principal/head of school and adult head coach agree to the following:
 - a. Your school administration approves of your school's current students representing your school at NYCFL speech and debate tournaments.
 - b. Your students are chaperoned at tournaments at all times by an adult approved by your school administration. At an in-person tournament, adult chaperones are responsible for being on-site with students at all times and for making sure your students follow all rules set by the tournament and the host school. At a virtual tournament, they must be accessible to the tab staff and your students to resolve issues. They are responsible for team attendance, judge preparedness, and checking team registration.
 - c. Your adult chaperones are further responsible for dealing with any medical or disciplinary emergencies which might arise involving students from your school.
 - d. All adults from your school attending NYCFL tournaments, either in-person or online, meet the requirements set by your school administration for adults who work with students in extra-curricular activities.
- 3) By signing this participation agreement, your school's adult head coach and head of school acknowledge that students may be participating in speech & debate competitions online using a video platform hosted on the National Speech & Debate Associations private server. You further acknowledge that during some parts of the tournament, such as the awards ceremony, students may be shown on screen as part of a live stream. Students will have the option to turn their cameras off during those times.
